### **Child Support Department:**

## a. Director vacancy:

D. Bohn reported that after input from the retiring Child Support Director and from the Social Services Director, she is recommending that the vacant Child Support Director position eliminated and replaced with a Child Support Lead Worker position, under the direction of the Social Services Director.

### b. Child Support Dept. consolidation with Social Services Dept.:

This action would also entail the consolidation of the Child Support Department with the Social Services Department. The committee discussed her recommendation. K. Anderson questioned if the Social Services Director's pay was going to be increased due to the added supervisory responsibility. D. Bohn responded that a pay grade increase was not anticipated.
